

Toll-Free Dialing Restrictions

Dial-in numbers are often subject to access restrictions enforced by telecommunications carriers. This document describes known access restrictions to toll-free numbers dialed from and provides incountry audio alternatives.

Access to toll-free numbers can also be restricted from payphones, hotels, corporate PABXs, and sometimes even land lines (a.k.a. fixed lines) using certain carriers.

From outside the country of assignment: Toll-free numbers are not reachable from locations outside the country where the number is assigned (e.g. a UK toll-free number can only be accessed by a caller from within the UK).

From hotels: Access to toll-free numbers may vary by hotel, and the hotel may impose additional access charges.

From pay phones: Access to toll-free numbers may vary by based on the company providing the payphone. Some payphones may require a payment to access a toll-free number, which may be returned on completion of the call.

From mobile phones: Access to a toll-free number can depend on the mobile carrier of the calling party and the relationship that carrier has with the carrier hosting the toll-free number. The calling party may need International Direct Dialing (IDD) even though the call is not an international call. Airtime may be charged to the subscriber. When roaming into foreign countries, access to the toll-free number might be blocked.

Audio connections to WebEx which utilize embedded voice (voice over computer) to/from a workstation (or mobile app) are not impacted by dialing restrictions.

Known, in-country toll-free dialing restrictions and alternatives are listed in Table 1.0. Where countries list "limited access" dialing in toll-free, that access is subject to local carrier transport agreements.

If a country is NOT listed, then there are no known dialing restrictions to an in-country toll-free number if one is available via the conference's global dialing link.
